



Utah State USBC WBA Hall of Fame

The purpose of the Hall of Fame is to honor bowlers of the Utah State USBC Women's Bowling Association (USWBA) that have performed tireless service for the general welfare and progress of the sport and those bowlers who have displayed superior performance in the game of American Ten Pins. All bowlers in both categories must have also displayed, at all times, a high level of integrity and sportsmanship while either serving the bowlers on the state or local level or competing in any local or state competition.

NOMINATIONS:

1. Nominations will be submitted by the members of the USBC Utah State Women's Bowling Association (USWBA) Board of Directors and any Utah State USBC Local Association.
2. Nominations will be accepted provided the candidate is or has been a resident of the State of Utah and is a member of USBC or has been a member of USBC (WIBC/YABA).
3. Nominations for USWBA Hall of Fame may be for a living member or posthumously.
4. The application should bear the signatures of at least three sponsors and be accompanied by sufficient information pertinent to the qualifications of the candidate.
5. Non-qualifying nominations will be returned to the submitting association or individual. Qualifying nominations will be kept on file for future consideration.

REQUIREMENTS/GENERAL CANDIDATE QUALIFICATIONS:

1. A living candidate must be a present or past member of USBC for at least 20 years with at least ten (10) years in the Utah State WBA (or one of its predecessor organizations. There are no age restrictions for posthumous candidates.
2. A candidate must have bowled in a minimum of at least ten (10) Utah State Women's Championship Tournaments, in a minimum of ten (10) local association tournaments and compiled an outstanding record of participation in certified USBC (WIBC/YABA) leagues and other local and state events.
3. Minimum of fifty (50) years of age.
4. A candidate must be of good repute and a respected member of the bowling family, and must display, at all times, a high level of integrity and sportsmanship on and off the lanes.
5. The Hall of Fame Committee will determine number of candidates selected each year from available qualified candidates. Only those considered by the Hall of Fame Committee to be qualified will be nominated to be elected into the Hall of Fame. The submitting Association or USWBA Board of Director shall be notified as to the disposition of the application whether still active (qualified), to be held for future consideration for up to three years (kept on file 3 years), or inactive (not enough qualifications and returned to the submitting board member of association).
6. Elected candidates will receive a plaque presented in person or posthumously if deceased.
7. Any military/mission assignment for candidates may be considered.
8. Meritorious candidates must have given distinguished service in the promotion of USBC (WIBC/YABA) Certified bowling activities through administrative or organizational work, or in any other manner deemed meritorious for a minimum of ten (10) years.
