## RULES OF THE MEETING

To the delegates assembled at the Utah State USBC WBA Annual Meeting, held at 1010 South Main Street – Richfield, Utah – March 21, 2015. We, the Utah State USBC WBA Board of Directors present for your approval, the following rules to govern this 2015 annual meeting.

1. Roberts Rules of Order Revised shall govern the procedures of this meeting. Provided they do not conflict with the bylaws of the Utah State USBC WBA and the USBC.
2. To be recognized, a delegate must address the Chair by Saying “Madam President” or Madam Chairwoman”. **She shall state clearly her name in full and the local association she represents.**
3. The 1<sup>st</sup> Vice President, Connie Paquette, shall seat visitors and the USBC members who are not delegates.
4. Delegate’s Credentials’ shall be accepted no later than 7:00 pm, Saturday, March 21, 2015. All delegates present will have the privilege of voting.
5. Delegates shall wear their identification badges **in full view**, on the right side, during the annual meeting.
6. All motions submitted at the annual meeting shall be stated in the affirmative.
7. A Delegate shall be permitted to speak **only TWICE** on any questions limiting each discussion to **TWO** minutes. Discussion shall be confined strictly to the motion on the floor and all questions and answers shall be directed to the Chair.
8. In order to expedite the business of the 2015 annual meeting, the delegates shall give courteous and full attention to the speaker having the floor.
9. Delegates desiring to leave the meeting must request permission of the Chair.
10. Exceptions to these rules may be made at the discretion of the presiding officer.

8<sup>TH</sup> ANNUAL MEETING MINUITES  
MARCH 22, 2014  
Called to order at 6:25 PM  
CRYSTAL INN – MURRAY, UTAH

President, Maureen Nelson called the meeting to order and welcomed all in attendance. She then asked for a moment of silence for our past President Donna Smith who passed away this last summer and for all the members we have lost during the course of the season.

Maureen introduced Director, Danielle Lusk to lead us in the pledge of allegiance.

Maureen thanked everyone for coming and stated how happy she was to see everyone. She then turned the time over to the Association Manager, Marnye Madrid for roll call.

Directors – Natalie Downs, Danielle Lusk, Flip Nicol, April Sanchez, Patty Fest, & Bobbie Randall  
Association Manager & Director – Marnye Madrid

The time was turned over to Director, Patty Fest for the Reading of the rules and the credentials report.

Attendance:

3 – Officers      7 – Directors      22 – Delegates for a total of 32, the majority vote will be 16

The time was turned back to President, Maureen Nelson. She explained that included in the packets was the minutes from last year's meeting and asked if all had a chance to read them or if the delegation would like her to read the minuets. Ruth Cox then made the motion to accept the minutes as printed if there were no changes, seconded by Anna Green. Then voted by voice, all in favor to accept the minutes as written with no unopposed.

Maureen then went over her presidents' message to the delegation explaining what we as a board have been doing this past year. Talking about our Website and Facebook pages and how we have worked to provide information to all the women bowlers on both sites. She talked about the new format of the tournament starting this year moving from a 5 person to a 4 person team. She expressed her and the boards understanding that it most likely was difficult for some teams to work with the 4 person format. She talked out the new squad format being utilized this year, how we were able to provide more squads for all events because we were running Singles, Doubles, & Team Events concurrently. This has proven over the first two weekends to provide a more efficient and time smart tournament. Less downtime and more bowling.

Maureen thanked the board for all their hard work and support over the past year. She welcomed Marnye Madrid as the new Association Manager as Teresa Maughan had to resign her position to take time to care for her husband who was experiencing some health issues.

Maureen then read the quote from her presidents' message to the delegation.

“We work together not always in harmony, but always in unity...”

She stated this was the goal of the board, to work together in unity. That we may not always agree but we always work together and in unity for the better of the bowling community. It is hoped that you as the delegation and members of the WBA can see this and continue your support.

The time was then turned over to Marnye for the Association Managers report.

Marnye started with explaining that those who know her know that she has a hard time talking in front of large groups of people and that if she passed out to forgive her and move on with the meeting. She asked if anyone would like her to read the letter from her to the delegation in the book. She thanked the board for their confidence and support and allowing her to take on the position of association manager. She then thanked the delegates and members of the WBA and hoped to do a good job for all. She stated that she felt the tournament was running well and smooth so far.

The time was then turned back to Maureen. She stated the Director Reports were in the book for all to look at but that she was going to give each director the opportunity to present their reports to the delegation.

- Barbara Owen, 2<sup>nd</sup> Vice – Annual Audit  
Barbara explained she had entered the report that came straight from the auditor, Paula Lewis. That Paula had stated we had made improvements over the previous year's audit and to keep up the good work. Barbara then explained the items in question from the audit were minor and had all been resolved prior to the meeting.
- Marnye Madrid, A.M. – Budget & Financials  
Budget – Marnye explained the report was in the book and asked if anyone had any questions. After a moment Maureen stated the delegation may have a question on the State Delegate, she explained the reason for the increase in expense had to do with it being in Reno, NV in previous years and the upcoming year it would be in Indianapolis, IN. and that we did not have a Hall of Fame this year as we hold it every other year so that is why we had no expense last year but were budgeting for this year. Anna Green asked why under awards we went from \$0.00 to \$1,200.00 Maureen then explained that this was because USBC would no longer be supplying awards so we needed to budget for that expense. Becky Anthony then asked why there was no money for suckers. Maureen explained that we just bought suckers for this tournament and felt we had enough to last for this season and would not need to order till the following fiscal year.  
Financials – Marnye explained the reports were in the book and that they had been generated by the previous association manager and she thanked her for that. Marnye then asked if anyone had any questions on any of the financials. On the General Financial Karen Pullman ask why we were paying for a meeting room for the annual meeting? She said that most places will give you a meeting room if you have people staying at the hotel you are holding the meeting in. Marnye responded with the cost on the financial was what was paid last year and not what this year was. Karen then asked what we were paying this year. Marnye responded with we were receiving a discount on the room but that we still had to pay a fee. Karen then asked what we were paying for our transportation fees. Marnye responded with \$0.40 cents a mile. On the State Tournament Financial Anna Green asked why there were two lines for trophies on the statement, one for 2012 and one for 2013. Maureen stepped in and explained that the trophies had always been a year behind and that we were attempting to move the trophy purchase to trophies for the current year to be purchased in the current year and that was why we had two years as we purchased double the amount to catch it up. On the Senior Tournament Financial Anna Green asked about the 2012 senior entry to nationals being paid out of the 2013 tournament. It was explained the reason is because it is the winners from the 2012 tournament

that go to the 2013 Senior Championship and if you win the 2013 you will go to the 2014 and so on. This is why it looks the way it does but it is a current year expense.

- Marnye Madrid, A.M. – Tournament Winners Previous Year & Current Year Stats  
The report of the winners is included in the book and was read by Marnye to the delegation. All winners were congratulated at the meeting and will be recognized at the tournament at the squad they are bowling and at that time will be awarded their trophies. Marnye stated the current high game and series for the tournament and that the numbers for this tournament were strong even with elimination of the 5 person team and the trending decline in tournament participation as seen on a national, state and local level throughout the country.
- April Sanchez, Director – Publicity  
The Publicity report is in the book but April wanted to reiterate what Maureen had stated earlier in the meeting. April stated that Publicity is a very important function of this board and along with exposure and communication of the board to the members of the WBA. April then explained how we have established our own domain name at [www.utahstatewba.com](http://www.utahstatewba.com) along with our own email under the same domain at [utahstatewba@utahstatewba.com](mailto:utahstatewba@utahstatewba.com). The purpose of this was to be able to get information out to the membership faster. Even though the agreement we had with the Utah BA was a good one, we wanted to have the ability to reach out to the members of the bowling community on a more personal level. We also wanted the membership to be able to reach us in an easier way and that was why we now have our own email address. We also have a Facebook page at [www.facebook.com/UtahStateUsbcWba](http://www.facebook.com/UtahStateUsbcWba). April then talked about the Yearbook and how we have gone to a digital version available for printing off of our website for anyone that would like to print it, but if anyone would like a printed and bound copy we would be happy to do that for a small fee and mail it out. Maureen then included if there were associations that would like to have information posted on our website or on our Facebook page to please send us the information. This is your website and Facebook page, not just the WBA. April then included that we have a tab for the Utah State Youth Association and that we will put all the State Youth information up as it is passed on to us by the Youth Association Manager. We as a board wanted to try and make sure they did not get lost in the system and make sure they have a way to communicate with the youth bowlers of the state.
- Patty Fest, Director – Hall of Fame  
Patty stated that the report was in the book for all to see and that she would not read it. She then said we will have a H.O.F. induction ceremony this year but we have not yet pinned down the date and as soon as we know where it will be held it will be posted on the website and on Facebook. She said the application had been removed from the website to be reworked and would be put back up once it was completed. She then asked the delegates to think about people in their local association that may be qualified for consideration to the Utah State WBA Hall of Fame and if they had any one to please consider submitting them to us for consideration.
- Bobbie Randall, Director – 2013 Jamboree  
Bobbie stated the report was in the book for all to read. She said the Jamboree was held in the Provo/Orem area and that every year it is a lot of fun for all who attend. That Steve Kloempken from Storm and David Prange who is our USBC Regional Manager were at the Jamboree. They both gave excellent presentations with a lot of information to share with the bowlers of the state.
- Connie Paquette, 1<sup>st</sup> Vice – 2014 Jamboree  
The 2014 Jamboree is scheduled to be held in the Northern Area. It will be held August 22<sup>nd</sup>, 23<sup>rd</sup>, & 24<sup>th</sup> on a Friday, Saturday, & Sunday, in Brigham City. We have been invited to the Storm facility for a tour to see them in production. The Jamboree meetings will also be held at the Storm facility. The Bowling Tournament will be held at the Center in Brigham City.

Connie then took a few minutes to explain why she had a short paragraph from her as she had to run to Idaho on personal business. She thanked the women bowlers for their positive and negative feedback because that is how we make changes and how we improve. That you said the wait time between squads was too long and that we heard what you were saying and that we worked hard this year to cut down on the wait time.

- Connie Paquette, 1<sup>st</sup> Vice – Ways & Means

Connie said this was something new as we never really had a petty cash and that this is what it will be used for. If we need ink we can use this to go get some ink. We will use it to purchase the raffle items for the tournaments. That each year this will be renewed for use at the tournaments.

- Patty Fest, Director – Utah State USBC Youth

Patty started with, for those of you that have been to the meetings before and have listened to my report, you know that I get involved that I get carried away and that I am going to do it again. Even though I am not the Association Manager anymore I am still very involved with the youth. The first thing is not good news, membership as of 02/28/2014 is 673 compared to last year of 887. I am not sure what the story is trying to say but one thing is for sure, we are losing our bowlers. I made a comparison of the locals to compare last year to this year. There is no one here from Washington County but they were up 4 bowlers. Great Salt Lake is up 111 bowlers but that is because of High School. We have a great program growing out of High School and our youth programs are growing a little bit. Northern Utah is down 52 bowlers, Millard is up 9 bowlers, Central Utah is down 27 bowlers, North Utah County is down 16 bowlers, Iron County is up 15 bowlers, and the Basin because of center issues there we had no participation. However, there is this wonderful lady down in Vernal that brings up a high school team every year. So what she did is, I (Patty) sent her some cards and she filled them out for 15 of her kids and drove them to Roosevelt so they could bowl enough games to come and compete in the State High School Tournament. So we do have some membership from Basin. I don't know what to tell you, I don't know. We have got to do something. We are losing our youth and that is our future. Ok on to some good news. The 5<sup>th</sup> Annual Utah High School Championship was held at Spare Time in Roy. We had 35 kids from around the state show up. On Friday night all the kids' names go in a hat and all mixed up and drawn out of hat and matched that way. They have no idea who they will be bowling with and they all had a blast. They compete for scholarship money, 1<sup>st</sup>, 2<sup>nd</sup>, & 3<sup>rd</sup> place, High game and High series. Saturday was the State High School Championship. We had 15 teams from Northern Utah, Salt Lake, Tooele, and Vernal. 1<sup>st</sup> place and 2<sup>nd</sup> place went to Olympus/Granger, 1<sup>st</sup> place and 2<sup>nd</sup> place was Copperhill. Trophies and Scholarship will be awarded at the High School awards function that will be held after the kids' state tournament. The Pepsi Tournament was held March 15<sup>th</sup> & 16<sup>th</sup> at Big City and tournament participation was down again, this is the second year in a row we had less than 100 entries. We were down 48%. We think it has to do with the tournament changing from handicap to scratch. We are sending to Buffalo this year 6 kids to compete in the junior gold. The 47<sup>th</sup> Annual Youth State Tournament will be held April 5<sup>th</sup>, 6<sup>th</sup>, 12<sup>th</sup> & 13<sup>th</sup> at Hill Field. Connie Paquette then asked if she could explain the procedure to have people allowed to come on to the base for the Youth to have the tournament at Hill Field. Connie explained it to everyone. Both said it is a wonderful center and if you get on the list to bowl a league to give it a try. The 12<sup>th</sup> Annual High 4 Tournament applications were sent to the proprietors as they are the ones who decide who will represent their house at the tournament. Patty then asked everyone to give the new youth association manager and the new youth president support as they learn their positions. Patty said she received permission from the youth board to continue handling the SMART Accounts for the youth for a little while longer. Patty then thanked everyone involved with the youth and asked all the State and Local Associations to get more involved with the youth as they are our future. Patty then asked if there were any questions.

Anna Green asked who the new AM and President were. Patty said the AM was a young man that came to her when he was 14 and said he wanted to help. His name is Jake Lund out of Northern Utah, the new President is out of St. George and his name is Glen Johnson. There were no further questions and Patty thanked everyone.

- April Sanchez, Director – Legislative

April said all was quiet on the legislative front for this year but that we should be prepared for the possibility of some next year. She reminded anyone that wanted to suggest a bylaw change on the state level that it needs to be submitted 45 days in advance and that our bylaws as well as the procedure for submitting a proposed change is posted on our website for anyone to review. She then drew attention to the legislative issues on the National Level and said we had them posted on our website for anyone to read as well as being available on bowl.com to review. That anyone going to the convention should review them carefully as a lot of them have to do with dues increases. April said that was all she had and thanked everyone. Patty then asked if she could add one more thing about the youth. She said as of August 1, 2015 the State Youth would be losing the .50 cents that it had been receiving. She asked that we all ask our local associations to remember the youth and try to set up something to pass on to the State Youth Association.

Maureen then took the floor again and thanked everyone for their reports. She then announced that we would hold our election process and turned the floor over to Nominating Committee. Patty Fest as the Committee Chair then presented the delegation with the following:

For the office of 1<sup>st</sup> Vice President

Running for office – Incumbent, Connie Paquette – no other applications were submitted

Patty asked Connie to stand so all could see her. Barbara Owen made a motion to accept Connie by acclimation; seconded by Jeri Lund, motion passed and Connie accepted the position.

One (1) Director – North \*

No Application – Vacant – no applications were submitted

There were no nominations from the floor and no applications submitted so no election was held for this position

One (1) Director – Central

Running for position – Incumbent, April Sanchez – no other applications were submitted

Patty asked April to stand so all could see her. Julie Poulson made a motion to accept April by acclimation; seconded by Jeri Lund, motion passed and April accepted the position.

One (1) Director – South

Running for position – Incumbent, Flip Nicol – no other applications were submitted

Patty asked Flip to stand so all could see her. Danielle Lusk made a motion to accept Flip by acclimation; seconded by Ruth Cox, motion passed and Flip accepted the position.

Upon completion of the elections Patty then thanked everyone.

Maureen then stated there were a few more things to be voted on.

#### One (1) Delegate National Convention

A motion was made by Barbara Owen to send Marnye Madrid, Association Manager, to represent the Utah State WBA at the National Convention; seconded by Jeri Lund, motion passed and Marnye accepted.

#### One (1) Alternate Delegate National Convention

A motion was made by Connie Paquette to have Maureen Nelson, President, listed as the alternate if for any reason Marnye is not able to attend the National Convention; seconded by Julie Poulson, motion passed and Maureen accepted.

#### Hosting of the 2015 Annual Tournament and the 2015 Senior Tournament:

The host area was set in the Southern area and there were only two centers that bid on both tournaments. Jack & Jill Lanes, American Fork & Jorgensen's Bowling Center, Richfield.

Mindy Pullman then asked if it was awarded to Jorgensen's and it being a smaller center if we would consider holding Friday Night squads. Maureen then stated her and Marnye had spoken with Jorgensen's and they said if they were chosen then it would be possible to hold Friday night squads if needed. Ruth then ask if they would have a mechanic on duty the whole time as we would most likely have to use all lanes and that would not allow us any room for break downs. Marnye responded with we had been assured if awarded the tournament there would be a mechanic on duty at all times to handle any break downs. Ruth Cox then asked if anyone had gone down there to look at hotel accommodations and such. It was then stated by Maureen that it was all included with their bid letter and also in the meeting book for them to look at. It was then explained that because only two centers had bid on the tournament there would only be one vote and the center that did not receive the vote for the annual tournament would be awarded with the Senior Tournament. Maureen as the ballots were being passed out then explained again that the vote to be taken was for the awarding of the 2015 Annual Tournament to be held in March. Jeri Lund then asked if Jack & Jill was the new or the old center. Maureen said it was for the one in American Fork or what is considered the old center and that they will not host a tournament in the new center. It was then asked again what vote we were taking first the annual or the senior. It was then again explained there would be no vote for the Senior Tournament only a vote for the Annual Tournament and the center that did not get the Annual Tournament would be given the Senior Tournament. As the ballots were being counted we did the drawing for the ball. The winner was Ticket Number 490590 / Debbie Larsen. The next drawing was for free team entry into the 2015 Annual Tournament all teams were entered in to the drawing and the winner was entry # 103 Get it Right.

As Voted by the delegates at the 2014 annual meeting it was decided that Jorgensen's would be awarded the Annual Tournament and Jack & Jill was awarded the Senior Tournament for the 2015 year. Connie Paquette made a motion to destroy the ballots and it was seconded by Anna Green, motion passed and the ballots were destroyed.

#### Unfinished Business – None

New Business – It was discussed that since USBC was eliminating awards so we asked the delegation to think about and suggest possible new awards to give out. Joanne Shelton asked what kind of awards we were giving out now. Maureen said we were doing pins for games and series. Eleanor Baker made the suggestion that we give out one pin per award earned example if you bowl three (3) 200 games you would only get one for the first one you bowl. Christina Carlson suggested that we look at having the awards that are average based, so if you bowl a 200 and you are a 140 average bowler you will get a pin

but if you are a 190 average bowler you would not get a pin. The general opinion was that all the ladies like the pins and for us to stay with the pins. Maureen then asked how the delegates liked the meeting books. She said we were entertaining the thought of going digital for next year. Maybe a PowerPoint presentation, or a digital format that can be seen on a tablet or iPad. The majority of the delegates said that would be fine. We then discussed the short season membership. There was a letter sent out by the BA to all association stating that all bowlers bowling in a short season league will have to join the BA. Maureen then explained that was not true for the Women bowlers of the State. That we as an organization choose not to collect the \$1.00 dues from the women who bowl in a short season league, it is only the men that will need to pay the extra \$1.00 as it stands right now. We also asked the women to take back this information to their associations.

Maureen Nelson asked if there were any further questions. Mindee Pullman then asked with us going to a smaller house for the annual tournament is we would consider holding a combined doubles and singles squad with no break between the squads. Maureen said that would be a good idea for us to look at and we would consider it. Maureen thanked her for the suggestion. Karen Pullman then requested to address the delegation to inform us that she would be hosting a coaching clinic starting Saturday mornings on April the 12<sup>th</sup> from 9:30 am to 11 am the cost is \$10.00. Maureen asked Karen to send us all the information so that we can get it all posted on the website and on Facebook. Barbara Owen added that all the local associations will now have to fulfill a coaching clinic for the new performance standards.

Maureen thanked the delegate again for attending the meeting.

Connie Paquette made a motion that we adjourn this meeting and it was seconded by Danielle Lusk, motion passed.

Meeting adjourned at 7:55 pm



\* After the closing of the annual meeting President Maureen Nelson then requested all board members to remain in the room for an emergency board meeting. The board gathered and discussed the vacant Director position in the North area. Maureen Nelson then recommended the appointment of Becky Anthony to the vacant North Director position. All board members were in favor and Becky was appointed to the Board to fill the vacancy effective August 1, 2014.

*Letter from the Association Manger*



## AUDIT COMMITTEE REPORT 2015

### To the Officers, Members of the Board of Directors and Delegates of Utah State USBC WBA:

On January 10, 2015 the year-end financials for the Utah State USBC WBA, for the fiscal year ended July 31, 2014, had been reviewed by the auditor, Paula Lewis, with the following notes:

#### FROM THE AUDITOR

1. Each year shows marked improvement in the bookkeeping/accounting of the Utah State USBC WBA.
2. Checks from the Gold operating account were reviewed for the period August 1, 2013, through June 30, 2014, to ensure the checks included two signatures and included warrants approved with two signatures. All checks had the required signatures of two officers and all warrants in the file included the required signatures of two officers.
3. Checks and deposits were cross-referenced to the bank statements for August, 2013, through July, 2014. All checks recorded in QuickBooks were correctly identified in the bank statements with the exception of outstanding checks that had not yet cleared the bank.
4. All payouts were examined to ensure they included a warrant signed by two officers.
5. The balance stated on the Gold operating account ties to the bank statement.
6. The balance stated on the balance sheet for the Gold Money Market account No. 8618 ties to the bank statement.
7. Statements for the CDs ending in 6799, 7546 and 7801 were not available for review. Marnye is looking for them. (Bank sent statement showing individual totals but has not sent individual statements)
8. The liability insurance backup paperwork was available and the file and is current.
9. Form 1099-Misc along with Form 1096 has been filed with the IRS.
10. Research on the Utah.gov website shows your entity is in good standing with the state of Utah until January 31, 2015. The registered agent is identified as Marnye Madrid.
11. Form 990 has been filed and accepted by the IRS. Your entity is in good standing with the IRS until the filing deadline in the next fiscal year.
12. The balance sheet and profit and loss statements of an organization are indicators of income versus expenses, as well as a method to compare trends from one year to the next. In prior year audits, we have discussed the need to break out income and expenses by tournament (state tournament and senior tournament) and also separate operational expenses from tournament expenses. In the past, this separation has not been accomplished and it has been difficult to account for income and offsetting expenses of each tournament. In addition, when the correct accounts are used consistently over the years, the Association is able to determine if income and expenses are increasing or decreasing compared to prior years for each individual tournament. Marnye has been working hard to correct the accounts. Discussion will be held with the audit committee with suggestions to further improve use of the proper accounts in order to have a more usable profit and loss statement.

Thank you for the opportunity to serve the Utah State WBA. I wish you great success with your upcoming tournaments. Paula Lewis, Auditor.


